BUSINESS LUNCHEON REPORT: SPEAKER JAMES GORE

Members of the Mark West Area Chamber of Commerce, along with a few guests, gathered at the first Chamber business luncheon since the beginning of the Covid pandemic. Our special guest speaker was Sonoma County Supervisor James Gore. Food was generously catered by Molsberry Markets, and a space was provided by Best Western Plus Wine Country Inn & Suites on Hopper Avenue.

Supervisor Gore opened his speech by reiterating his goal of working to support the community, complete with a water-bottle toast to the business owners and representatives present. He spoke on his experiences with the various tasks required of a county supervisor, emphasizing the need to continue pushing through the chaos of busywork in order to keep moving forward with the real goal of improving the county. He also emphasized that he loves connecting with business owners. "I'm really trying to make sure that I find time with you guys, and so I really appreciate [this sort of meeting]."

The focus then shifted to water conservation. Notably, he stated that while there is plenty of reason to be thankful for the rain that has fallen lately, it will not be nearly enough to fully cure the drought. Water conservation and alternative sources of water are continually being sought by county officials, and he noted that certain ideas, such as desalination, are not financially viable. In the meantime, Supervisor Gore put out an off-repeated call to action for citizens to continue adopting less wasteful practices,

warning that new laws and regulations could come into effect if there is not a significant reduction in water usage – particularly during the summer months.

Supervisor Gore then turned his attention to Ron Calloway's continued work as the Mark West Unified School District Superintendent. While both thanking Ron for his work and reminding attendees of Ron's accomplishments as superintendent, Supervisor Gore also reminded those present that Ron is soon up for reelection.

Among the other topics addressed was a call to action for improved vegetation management and other fire prevention efforts. Supervisor Gore noted that many of the works of the current fire district have been born from the efforts of longtime Chamber member and former Fire Chief Doug Williams.

Other topics touched on briefly included the ongoing discussions with local Native American tribes and the Bureau of Indian Affairs (BIA) regarding the recognition of the Koi Tribe, the status of the Sonoma County Airport and its need for a new environmental impact report, and Supervisor Gore's own appointment to FEMA's National Advisory Council. Supervisor Gore introduced two members of his staff: Keith Roberts, and Chief of Staff Jenny Chamberlain. A Q&A session took up the remainder of the meeting.

In the end, the luncheon with Supervisor Gore was a tremendous success. The Chamber thanks Supervisor Gore for taking the time to discuss these topics with Chamber members, and wishes him luck in his continued efforts to keep improving Sonoma County.

SONOMA COUNTY FIRE DISTRICT: CURRENT EVENTS

The Sonoma County Fire District Board of Directors has voted to approve moving forward with a consolidation with the Bodega Bay Fire Protection District. This consolidation will increase the current staffing level at the Bodega Bay fire station from three on-duty personnel to five, while decreasing the fire tax for Bodega Bay residents by 70%. The increase in staffing will ensure that paramedic services will remain in Bodega Bay when their ambulance transports patients. The agreement now goes to the Sonoma County Board of Supervisors on November 16th. If approved, the Fire District will enter the LAFCO process (Local Agency Formation Commission), a process that helps ensure orderly changes in governmental jurisdiction.

SONOMA COUNTY NONPROFITS RECEIVE RESILIENCY AWARDS

Since 2018, 200 fire departments and fire agencies statewide have received funding through the Wildfire Safety and Preparedness Program (WSPP). These grants are part of a broad program that is administered and managed by the California Fire Foundation (CFF). Pacific Gas and Electric Company supports the program with \$1.4 million in charitable funding.

Funding targets specific communities identified as having extreme or elevated fire risk. The WSPP focuses on two key areas to help keep communities safe. First, the Wildfire Safety Campaign that features fire safety education in multiple languages, to promote early evacuation during fires. This fire safety messaging is delivered via radio, television, and digital ads, and outdoor billboards in high fire-threat areas. Second, the CFF awards grants to fire departments, agencies, and community groups in support of projects and programs focusing on wildfire/disaster prevention, preparedness and/or relief and recovery assistance. BUSINESS SPOTLIGHT DEFENSE BLOCK SECURITY: KEEPING PEOPLE SAFE

Feeling safe is something that everyone values. Whether at a sporting event, a town gathering, or even just entering a store, it is important that there is a feeling of safety. In many cases, this feeling is possible because of the general nature of the environment, but in other cases it is because of the actions of a security service. These services, separate from the normal police, are invaluable in keeping many of the places we visit daily safe and secure. In Sonoma County, one such company is Defense Block Security, a private security service that seeks to provide safety for a wide variety of venues.

Founded in 2006 by Kenny Neideffer, who was joined in 2019 by Fred Pena, D-Block Security was built on the idea of staying community-focused within

Sonoma County. It is easy enough for a security service to offer guards that look big and intimidating in order

to ward off trouble, but it is important that security guards are also able to be friendly and courteous to the people they are protecting. When a business, organization, or even the county hires D-Block, they are not getting just an intimidating guard who scares off troublemakers, but a person who has chosen to make their career out of keeping others safe. One of Fred Pena's favorite parts of the job is seeing his employees change over time. "I like seeing the change in people as they become professionals and improve their personal lives," Fred says. "We're not just providing a body, but a person."

Within Sonoma County, D-Block has been able to provide services such as guarding non-congregate sites, or even providing security at events such as the Windsor Chili Cook Off.

With the local community as a focus and inspiration, D-Block has also sought to work with the community on projects outside of security services. Fred, who was born and raised in Windsor, believes that actions speak louder than words, and has worked to demonstrate that through D-Block's support of local community projects. One of their major contributions has been their sponsorship of the Santa Rosa Rugby Club. D-Block support has helped the SR Rugby Club stay together, acquire new uniforms, and participate in a major tournament in Colorado. Other contributions from D-Block have included donating to the Mark West Little League, as well as TLC Child and Family Services.

D-Block Security was also able to join the Mark West Area Chamber of Commerce this year. Though D-Block is new to

the Chamber, Fred Pena's presence at Chamber socials has allowed the company to form relationships with other businesses in the Chamber, with the hope that these relationships will continue to flourish in the future.

At the end of the day, hiring Defense Block Security to provide security is not hiring a nameless face to stand watch, but a person who prides themselves on being able to keep safe whatever they are assigned to guard, while also being able to interact with the community in a positive way. Whether in need of one security guard or several, D-Block security is ready to provide their very best to their community. CREATIVE SONOMA ANNOUNCES GRANTS FOR CULTURAL ARTS IMPACT

Creative Sonoma is pleased to announce that grants are available for nonprofit cultural arts organizations producing activities that occur before December 30, 2022. The County Board of Supervisors approved \$125,000 to fund these grants to support the cultivation of a vibrant community and economy through the arts to serve local residents and visitors.

Grants are available to support cultural arts activities across Sonoma County that will occur between January 1, 2022 and December 31, 2022. Nonprofit organizations, including museums and culturally specific organizations, that produce arts and culture programs, services, and events are eligible to apply. The application portal opens on October 28 and the deadline for applications is December 2, 2021.

Grants will fund cultural arts activities that contribute to the social cohesion of our communities countywide, in neighborhoods, or with student populations. Applications for projects that also advance the community's awareness and understanding of environmental sustainability are encouraged. Successful applicants will demonstrate a commitment to providing equitable access to and participation from communities of color and other traditionally marginalized communities.

REDISTRICTING UPDATE

The December deadline for Sonoma County to pick new boundaries for its five supervisorial districts is looming. Every 10 years, Sonoma County must redraw its district boundaries using new Census data – this process is called redistricting. The new election lines determine which communities are placed in each supervisorial district, and voters within each district will elect one of their own as County Supervisor. Redistricting is happening now, and the County of Sonoma is asking for your help to plan, draw, and redivide new County districts.

Redistricting balances population counts within each supervisorial district, and sharing your unique point of view will help ensure our diverse communities are fairly represented by the County Board of Supervisors to have a voice at the decision-making table on issues that impact our day-to-day lives.

Redistricting is different from most issues that come up in County government. Instead of being limited to saying you support or oppose a County-prepared ordinance or resolution, local residents were encouraged to draw new districting maps themselves. The proposed maps will be taken under consideration when redistricting decisions are made.
